*Get ready to take the credit! The Maryland Renters' and Homeowners' Property Tax Credit Program helps renters and homeowners account for the skyrocketing housing associated costs in Maryland. In 2017, approximately 47,000 homeowners received an*



*average of \$1,339 in tax relief, while more than 8,800 renters received an average of \$402 in tax relief. These two tax credit programs helped more than 55,000 Marylanders save more than \$65 million in taxes. In this workshop, attendees will walk away excited and ready to educate Maryland homeowners and renters about the availability of these tax credits. We will discuss how to navigate the application process, the importance of increasing awareness, the impact on tax sale, and opportunities to move forward.*

*Financial institutions are a likely source for private investment in the community development, affordable housing, and accessible mortgages that our communities need to thrive. The Community Reinvestment Act (CRA) requires banks to meet the credit needs of low- and moderate-income communities they serve through loans, investments, products, and services. CRA enforcement relies on the community to communicate its credit needs and proposed solutions to financial institutions and federal regulators. At this training, we’ll review how community members, nonprofits, and neighborhood-based organizations can leverage this law to bring private investments to their community.*
